1. Conditions of Use

Reports cannot be sold, transferred or used by any other party, other than the Purchaser. The Vendor will do its best to ensure that services provided by its Internet Service Providers and Web Hosting businesses are in operation. The Vendor is not responsible for any break down in delivery services of reports or access to the website.

2. Report Credits

Individual reports purchased do not need to be completed in a given period and can carry forward until the number initially purchased is used. Additional reports can be purchased at any time at the current price and conditions. Unused reports cannot be returned for a refund.

3. Report Payment

The Purchaser will pay the Vendor based on the prices included in this Order Form, using one of the methods set out.
